November 6th Workshop #12 (Dr. Erin Dugan) 9am-12pm

Therapeutic Approaches in Play Therapy 3.0 CEUs

There are many approaches used in play therapy including Non-Directive, Directive, Filial, Group Play Therapy, Family Play Therapy, Theraplay, and Child-Parent Relationship Therapy. These approaches are all utilized in similar, but different manners and are used in separate times dependent upon the need for the family system and the identified patient. Historically, beginning play therapists are taught from a nondirective framework. This workshop aims to expand the beginning and intermediate play therapist's case conceptualization and treatment planning skills. Participants will be provided on overview of the approaches used in play therapy and an opportunity to receive decision tree guidelines in developing best practice/approach for clients.

November 11th Workshop #13 (Dr. Krystal Vaughn) 9am-12pm

Supervisory Relationship 3.0 CEUs

This workshop will focus on challenges and successes that may occur in supervision. Attendees will be presented with interactive lessons and mock cases addressing issues such as interpersonal issues, power and authority, conflicts, and issues of trust.. The presenter will lead large and small group discussions.

December 4th Workshop #14 (Dr. Erin Dugan) 9am-12pm

Filial Therapy and Child-Parent Relationship Therapy 3.0 CEUs

This workshop will focus on how to actively engage parents as partners in the therapeutic process in working with minors in a counseling setting. A variety of parenting approaches will be explored, with heavy emphasis on van Fleet's Filial Therapy and Landreth's 10-week filial therapy modality, entitled Child Parenting Relationship Enhancement training (CPR-T).

December 11th Workshop #15 (Dr. George Hebert) 9am-12pm

Assessment and Interventions for Disruptive or Impulse Control Disorders 3.0 CEUs

This workshop will provide participants strategies for addressing children and adolescents suspected of having a disruptive or an impulse control disorder. This training activity will utilize a multi-modal assessment strategy which includes the results of interventions as a means of informing the diagnostic decision. Assessment and intervention procedures addressed will be consistent with DSM-5 diagnostic criteria and eligibility for Louisiana regulations for special education eligibility.

December 11th Workshop #16 (Dr. Krystal Vaughn) 9am-12pm

Introduction to Ethical and Legal Issues in Supervision 3.0 CEUs

This workshop will explore ethical and boundary issues faced in clinical supervision. The ACA

Ethical decision making model will be used as the foundation for discussions. Participants will be presented with mock cases, utilizing the ACA model, working collaboratively to explore the principles of ethical decision making. Boundaries issues in supervision will also be explored through small and large group discussion. Participants should be familiar with the ACA Code of Ethics prior attending.
