

### Workshop description, rationale, and learning objectives:

The emphasis of this workshop, *Counseling Theory in Practice*, is on bringing contemporary theories to life by formulating an integrative counseling style that addresses the thinking, feeling, behaving, relational, and contextual aspects of human functioning. Emphasis is given to developing an integrative approach to counseling practice and to personalizing counseling for each client. The integrative model demonstrates ways to employ a variety of techniques at the various stages of counseling – from the beginning of the counseling relationship to the evaluation and termination of the therapeutic process. The presenters will explain their personal perspectives on developing an integrative approach. Both the advantages and disadvantages of an integrative approach to counseling are described. Each theory is discussed with a common framework including: key concepts of the theory; therapeutic goals; therapeutic relationship; techniques; multicultural applications; and contributions. Emphasis is on the practical applications of the various theories to working with diverse client populations. Presenters welcome questions and audience involvement throughout the day.

### About the presenters:

Gerald Corev. EdD. ABPP. is Professor Emeritus of Human Services and Counseling at California State University at Fullerton. He presently holds the position of Distinguished Visiting Professor of Counseling at the University of Holy Cross in New Orleans, where each semester he teaches intensive courses in counseling theories, group counseling, and ethics. He received his doctorate in counseling from the University of Southern California in 1967. He was awarded an honorary doctorate in Humane Letters in 1992 from National Louis University. He is a Diplomate in Counseling Psychology, American Board of Professional Psychology; a licensed psychologist; and a National Certified Counselor. He is a Fellow of the American Psychological Association (Division 17, Counseling Psychology; and Division 49, Group Psychotherapy); a Fellow of the American Counseling Association; and a Fellow of the Association for Specialists in Group Work. Both Jerry and Marianne Corey received the Lifetime Achievement Award from the American Mental Health Counselors Association in 2011, and both of them received the Eminent Career Award from ASGW in 2001. Jerry was the recipient of the Outstanding Professor of the Year Award from California State University at Fullerton in 1991. He received the Thomas Hohenshil National Publications Award, which was presented at the American Counseling Association's Virtual Conference in 2021. He is the author or coauthor of 16 textbooks in counseling currently in print, along with more than 70 journal articles and book chapters. Several of his books have been translated into other languages. Theory and Practice of Counseling and Psychotherapy has been translated into Arabic, Indonesian, Portuguese, Turkish, Korean, and Chinese. Theory and Practice of Group Counseling has been translated into Korean. Chinese, Spanish, and Russian, Issues and Ethics in the Helping Professions has been translated into Korean, Japanese, and Chinese.

With his colleagues, Jerry has conducted workshops in the United States, Germany, Ireland, Belgium, Scotland, Mexico, Canada, China, and Korea with a special focus on training in group counseling.

# Workshop rationale and learning objectives:

Rationale: Counseling Theory in Practice is based on contemporary counseling theories, with an emphasis
on the practical applications to counseling practice. The workshop is aimed at helping participants formulate

their personal perspective on counseling practice. Counselors working with diverse client populations in a variety of settings need to be familiar with a range of theoretical approaches in order to best serve the needs of their client group. This full-day workshop is based on the assumption that counseling practitioners need to have a firm grasp of theory as a basis for effective practice. This workshop provides an overview of key concepts and techniques based on wide range of contemporary theoretical approaches to counseling.

• Learning Objectives: After attending this workshop, *Counseling Theory in Practice*, it is expected that participants will be better able to do the following:

• Describe how to conceptualize a variety of counseling techniques and approaches in an integrative approach.

· Understand the role of cognition, emotion, and behavior in counseling.

•Understand the contributions and limitations of contemporary theories of counseling in working with culturally diverse clients.

- · Identify key concepts and selected techniques associated with the various counseling theories.
- Explain how the therapeutic relationship is central to outcomes, regardless of one's theoretical orientation.
- Describe the basic ideas of their own counseling orientation and personal style of counseling practice.

• Participants will be invited to ask questions and will receive an extensive package of notes describing the key themes explored in the workshop.
