### **Formal Mentoring and Advisor**

### **Administrative Responsibilities**

#### **Departmental**

- **Academic Fieldwork Coordinator (5/2018 – 7/2021)** As Academic Fieldwork Coordinator, I was responsible for placing all students in their five clinical rotations across their time in the program, ensuring students had all requirements needed, i.e. background check, immunizations, etc., and supported students for success. I updated the Level I Fieldwork Manual, Level II Fieldwork Manual, and the Fieldwork Educator (FWE) Manual. I co-created a FWE continuing education seminar with the Department of Physical Therapy and provided this CEU event to over 100 therapists at multiple sites across southern Louisiana. In addition, I made multiple site visits to ensure good experiences for the students, strengthened ties to the community, and developed many new affiliation agreements across the country.
- **Department Head (2/2023 – Present)** As Interim and permanent Department Head, I have successfully led the Department through an ACOTE Interim Report and an Annual Report. I have led the updates to our departmental strategic plan, and both created and updated departmental policies and procedures. I have created a formal procedure for faculty hiring and orientation in addition to improving the new student orientation. I have spearheaded multiple improvements to the physical spaces for both faculty and students and created bi-annual 'back to school' talks for students as well as focus groups for student input into specific issues. Intra-departmental communication is now open and transparent, including providing budget information to faculty and staff. I have also led a curriculum over-haul mandated by our accrediting body, shortening the program from 28 to 23 months.
- **Admissions Chair (7/2021 – Present)** As Admissions Chair for the Department of Occupational Therapy, I organized a new system of interviewing applicants that allowed every faculty member to meet every applicant. I created more objective rubrics for interviews and writing samples, reduced bias by having two faculty grade each essay and writing sample without knowledge of the applicant's name, and facilitated agreement among faculty committee members on how each item should be weighted for a consistent formula to be used across all applicants. I lead the organization of the applicant interview days and all communication with applicants.

- **Co-Chair Honors Committee (8/2022 – 8/2024)** As co-chair of the SAHP Honors Committee, I co-organized all aspects of the SAHP Pre-Commencement Ceremony, including all communications with the graduates and faculty, ceremony site, food selection, order of the ceremony, invitations, and more. I spearheaded updates to the SAHP Chancellor's Award and Dean's Award to differentiate one from the other and created a more objective grading rubric.
- **Secretary of Faculty Assembly (8/2020 – 7/2022)** As secretary, I informed SAHP faculty of upcoming meetings and their right to request an addition to the agenda. I took detailed minutes and posted them for faculty review immediately
