As the course director for this lecture and lab course, I developed and delivered body system lectures while also instructing and assessing 30 students on performing comprehensive physical examinations through weekly lab sessions. The course consisted of 12 lectures and 12 hands-on lab sessions, ensuring a strong foundation in both theoretical knowledge and practical skills. In addition to leading instruction, I designed, administered, and graded weekly assessments to evaluate student comprehension during the classroom phase. This 4-hour credit course is taught each summer.
- 2015-2018 Course Director, PYAS 6558, Differential Diagnosis
As the course director for this lecture course, I created and taught the course content, instructional activities, assignments and assessments. Additionally, I evaluated student performance and conducted assessments of the course to ensure its effectiveness and relevance. The course consisted of 12 lectures, providing comprehensive coverage of the subject matter. Enrollment for the 3-hour credit course was 30 students per year, taught each summer.

As the course director for this lecture course, I was responsible for coordinating three sections of the course: Radiology, Laboratory Science, and EKG. In this role, I managed the scheduling of guest speakers, created and administered the student assessments, and conducted course evaluations to ensure quality and alignment with learning objectives. Enrollment for this 3-hour credit course was 30 students, taught each fall.

As the course director for this lecture/lab course, I was responsible for scheduling guest speakers and delivering several lectures within the course. this 7-hour credit course was between 30 and 35 students, taught each fall.

This course includes a lab component where students learn and practice history-taking skills in a hands-on setting. The course comprises 18 lectures and 10 lab sessions, providing a comprehensive blend of theoretical instruction and practical application. Enrollment for this 3-hour credit course is 35 students, taught each summer.
