Course Director 2018-2023: Co-Director 2023-2025	<u>Family Medicine Clerkship</u> – PYAS 6559 The eight-week family medicine clerkship is a required component of the curriculum, with students placed at sites throughout Louisiana, including both LSUHSC and private providers. During this clerkship, students are responsible for documenting patient encounters and clinical skills competency, submitting encounter logs, completing self and preceptor evaluations, and passing an end-of-rotation examination. To ensure effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted in accordance with ARC-PA requirements, supplemented by regular communication. The course enrolls 35 students annually.
Course Director 2018-2023: Co-Director 2023-2025	Emergency Medicine Clerkship – PYAS 6567 The four-week emergency medicine clerkship is a required curricular component, with students completing rotations at University Medical Center under the supervision of LSUHSC faculty. During the rotation, students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and pass an end-of-rotation examination. To maintain effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, augmented by ongoing communication. The course enrolls 35 students annually.
Course Director 2018-2023: Co-Director 2023-2025	<u>Internal Medicine Clerkship</u> – PYAS 6560 The four-week internal medicine clerkship is a required curricular component. Students complete rotations at various sites throughout Louisiana, supervised by both LSUHSC faculty and private providers. During this rotation,

students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and pass an end-of-rotation examination. To ensure effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, supplemented by ongoing communication. The course enrolls 35 students annually.

Pediatric Clerkship – PYAS 6561
The four-week pediatric medicine clerkship is a required curricular component. Students complete rotations at various sites under the supervision of LSUHSC faculty. During this clerkship, students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and pass an end-of-rotation examination. To maintain effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, supplemented by ongoing communication. The course enrolls 35 students annually.

Course Director 2018-2023: Co-Director 2023-2025 Psychiatry Clerkship – PYAS 6566 The four-week psychiatry clerkship is a required curricular component. Students complete rotations at various sites under the supervision of LSUHSC faculty. During this rotation, students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and pass an end-of-rotation examination. To maintain effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, augmented by ongoing communication. The course enrolls 35 students annually.

Course Director 2018-2023: Co-Director 2023-2025
General Surgery Clerkship – PYAS 6565
The four-week surgery clerkship is a required curricular component. Students complete rotations at University Medical Center under the supervision of LSUHSC faculty. During this rotation, students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and pass an endof-rotation examination. To maintain effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, supplemented by ongoing communication. The course enrolls 35 students annually.

During the rotation, students document patient encounters and clinical skills competency, submit encounter logs, complete self and preceptor evaluations, and submit documentation for virtual patient encounters conducted via Aquifer. To maintain effective communication and a strong preceptor-student relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, supplemented by ongoing communication. The course enrolls 35 students annually.

Course Director 2018-2022: Clinical Preceptorship Clerkship – PYAS 6568 The eight-week preceptorship was a required curricular component providing students with advanced clinical experience in a medical or surgical specialty area. Students propose a specialty of interest, and the program coordinates with clinical sites and preceptors to secure placements. During the preceptorship, students were to document patient encounters and clinical skills competency, submit encounter logs, and complete self and preceptor evaluations. In addition to coordinating placements and providing student feedback and grading, significant time was dedicated to establishing and maintaining relationships with community clinical sites and providers to execute affiliation agreements and ensure a wide range of clinical experiences for students. To maintain effective communication and a strong preceptorstudent relationship, annual site visits, coordinated with preceptors, are conducted per ARC-PA requirements, supplemented by ongoing communication. The course enrolled 35 students annually.

Course Director 2018-2019: Co-Director 2019-2020
Clinical Practice Issues – PYAS 6557
Clinical Practice Issues, offered in the final semester of the PA program, prepares students for professional practice through a combination of assignments and lectures addressing advanced clinical practice issues affecting the physician assistant profession. The curriculum encompasses topics such as billing and coding, licensure, financial management, hospital credentialing, state/national/international practice regulations, and professionalism. The course has an annual enrollment of 35 students.

- Course Director 2018-2019: <u>Seminar I</u> PYAS 6563 One seminar course is taken each semester of the clinical year of PA school. This course meets one day each month when students return from clinical rotations. Students present clinical cases, reflect on clinical experiences, and prepare for the next clinical experience through interactive cases and OSCEs.
- Course Director 2018-2019: <u>Seminar II</u> PYAS 6569 One seminar course is taken each semester of the clinical year of PA school. This course meets one day each month when students return from clinical rotations. Students present clinical cases, reflect on clinical experiences, and prepare for the next clinical experience through interactive cases and OSCEs.
- Course Director 2018-2019: <u>Seminar III</u> PYAS 6576 One seminar course is taken each semester of the clinical year of PA school. This course meets one day each month when students return from clinical rotations. Students present clinical cases, reflect on clinical experiences, and prepare for the next clinical experience through interactive cases and OSCEs.

# **Curriculum Development/Implementation**

2020 Expanded Cohort Size

Contributed to the expansion of the LSUHSC PA Program cohort size by 5 students, participating in the curriculum revision process to accommodate the increased student population. This involved meeting with University administrators, the registrar, clinical sites and preceptors to ensure the quality of education and clinical experiences remained consistent despite the larger cohort. This expansion resulted in a 17% increase in class size which contributed to meeting the mission of the PA Program to meet the healthcare needs of the state.

2020 Telehealth Clerkships during COVID-19

Developed and implemented telehealth clerkships in response to the challenges posed by the COVID-19 pandemic. This involved adapting existing clinical experiences to a telehealth format, recruiting telehealth preceptors, and developing new telehealth-specific learning activities. This innovative approach ensured the continuity of student clinical education during a time of significant disruption and provided students with valuable experience in delivering telehealth services.

2021 Restructured the Clinical Year

Redesigned the clinical year, transitioning the structure from 11 to 12 blocks. This involved designing the new block structure, developing new clinical rotation schedules, and collaborating with clinical sites and preceptors. The restructuring aimed to provide more flexibility in student scheduling and to increase available core and elective clerkships for our students.

2022 Created New Clerkship Course

Participated in the restructuring of the Preceptorship Clerkship, evolving from a single preceptorship experience to a two-part sequence (Preceptorship 1 and 2). This involved defining learning objectives for each preceptorship, creating syllabi, developing assessment tools, and ultimately having the course change approved by Academic Affairs. The revised structure allowed for increased opportunities for student clerkships in different medical specialties.

#### 2022 Developed Women's Health Clerkship

Collaborated to develop and implement a new Women's Health clerkship course. This involved obtaining clinical sites from multiple preceptors, establishing a modified clerkship schedule, and creating assessments to supplement clinical learning experiences. This allowed the PA program to meet accrediting standards without having a traditional Women's Health clerkship.

## 2023 Realigned Clinical Syllabi

Contributed to the realignment of clinical syllabi and evaluations to comprehensively incorporate all program competencies, learning outcomes and instructional objectives. This involved rewriting clerkship syllabi and creating new evaluations to coincide. This systematic approach ensured that all aspects of the curriculum were aligned with program goals and that student learning could be effectively assessed.

#### 2023 <u>Redeveloped Women's Health Clerkship</u>

Collaborated to develop and implement a new Women's Health clerkship course. This involved obtaining clinical sites from multiple preceptors, establishing a modified clerkship schedule, and creating assessments to supplement clinical learning experiences. This allowed the PA program to meet accrediting standards without having a traditional Women's Health clerkship.

#### **Formal Course Responsibilities**

- 2018-2020 <u>Lab Instructor Physical Diagnosis, PYAS 6553</u> During the summer semester, I dedicated three hours weekly to supervising physician assistant students in physical diagnosis, providing formative evaluations of their physical examination skills.
- 2018-2024 <u>Lecturer Pathophysiology, PYAS 6554</u> As a lecturer for this course, I prepared and presented 2-three hour lectures on neurologic pathophysiology for PA students. I also created a case study and MCQ questions for assessment.

During the entirety of the clinical year, I participate in the formative and summative assessment of PA students for OSCEs.

- 2021-2025 <u>Lab Instructor Physical Diagnosis, PYAS 6553</u> During the summer semester, I graded PA students final assessment of physical examination skills.
- 2022-2023 <u>Team Up Grader</u> As a grader for the Interprofessional Education (Team Up) program, I evaluated student team projects, assessing their collaborative efforts, communication skills, and application of interprofessional principles. This involved reviewing project deliverables, such as presentations, written reports, and reflections, providing constructive feedback to students on their teamwork dynamics, understanding of diverse professional roles, and ability to address complex healthcare challenges from a collaborative perspective.

#### Formal Mentoring and Advisor:

2018-2025 Provide academic advising to PA students across multiple cohorts and phases of the curriculum.
