ABOUT THE SPEAKERS



George W. Hebert, Ph.D. is a Clinical Associate Professor in the Department of Counseling at the Louisiana State University Health Sciences Center - New Orleans (LSUHSC-NO) and also serves as a faculty member in the Physician Assistant's Program in the Department of Interdisciplinary Human Studies. Previously, Dr. Hebert served nine years as the training coordinator/director for an APA accredited program in School of Psychology at the LSU Health Sciences Center in the Human Development Center. Additionally, he had served a total of eight years providing psychological services and directing an outpatient mental health clinic for children and adolescents in Louisiana. He also served a total of six years as a school psychologist in both rural and urban settings in Louisiana. Finally, Dr. Hebert had been a part-time faculty member in the psychology department at the University of New Orleans for many years.



Erin Dugan is the Dean of the LSUHSC School of Allied Health Professions, a Professor of Counseling, and the Clinical Director of the LSUHSC Child & Family Counseling Clinic. In 2006, Dr. Dugan established the LSUHSC Child and Family Counseling Clinic, where she remains its Clinical Director. The clinic provides mental health services to children and families in the greater New Orleans area and offers internships to students and graduates seeking mentorship, supervision, and training. Dr. Dugan is also a recognized leader at the national and state levels. A National Certified Counselor, Licensed Professional Counselor Supervisor, and Registered Play Therapist Supervisor, she was named Chair of Board of Directors for the national Association for Play Therapy in 2020. Dr. Dugan was elected President of the Louisiana Association for Play Therapy in 2011 as well as the Louisiana Association for Counselor Educators and Supervisors in 2010.



Holly Walters holds a Ph.D. in Counselor Education from Oregon State University. She is a Licensed Professional Counselor Supervisor (LPC-S). Currently, she is an Assistant Professor at LSUHSC in New Orleans. She is an alumnus of the program graduating with a Master of Health Sciences in Rehabilitation Counseling. She earned her Bachelor of Science in Psychology from the University of New Orleans. Dr. Walters has worked in outpatient mental health settings with the state for over 10 years as a clinician and a program director. Her research interest includes suicide prevention, risk reduction, and the use of popular culture in therapy. She co-runs a blog that integrates pop culture into learning healthy coping skills, therapypopculture.com.

The purpose of this workshop is to compliment and continue the content of the previous Diagnosis workshop. Specifically, this workshop will focus on a general framework from moving from general, broad assessments to disorder assessments to reach a diagnostic conclusion. Disorders with high prevalence rates will be highlighted with recommendations on using readily available assessment tools. Finally, participants will be invited to share their diagnostic concerns with the presenters for collegial and ethical problem solving.

- 1. Participants will be oriented to an assessment framework that allows the clinician to systematically move from broad to specific assessments to ensure diagnostic accuracy.**
- 2. Participants will gain further knowledge of assessment tools available to them and receive instruction on their use to best create the evidence for the diagnostic conclusion.**
- 3. Participants will share past dilemmas around diagnosis and learn from the presenters on strategies to navigate an ethical path forward - including consultation and referral.**
